This document shows the questions included in the online application form for this program. It will help you prepare your responses and the mandatory attachments you need before you apply online.

Instructions

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

A red asterisk * indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

Saving your responses

You can save your changes at any time by using the Save button.

To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

You can modify saved responses up until you submit your application.

Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to the participant inviting them to assist with your application.

Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

A. Program selection

Before you start your application, we need to first identify what type of entity is applying.

Some programs we offer allow entities without an ABN to apply. The form is designed to accommodate these entities. However for this grant opportunity, an ABN is mandatory. If you do not have an ABN this grant opportunity will not appear in the program selection at the bottom of the first page and you will not be able to continue.

If you are a trustee applying on behalf of a trust we will need details of both the trust and trustee.

A.1. Program selection

You must select from a drop-down menu the program that you are applying for. If you have been provided with an Invitation code, you will be able to enter it here which will select the program for you.

- Field 1 select – Carbon Farming Outreach Program
- Field 2 select – Carbon Farming Outreach Program

When you have selected the program, the following text will appear.

This grant opportunity will run over three years from 2023-24 to 2025-26.

The grant opportunity was announced as part of the Carbon Farming Outreach Program. Up to \$17.5 million is available for this grant opportunity.

The objectives of the program are

- support farmers and land managers to make decisions to reduce emissions
- build capacity of trusted advisers to deliver independent advice
- facilitate access to clear, consistent and culturally appropriate information on carbon farming and low-emissions technologies and practices.

The maximum grant amount is \$17.5 million and the minimum is \$1 million.

You should read the [grant opportunity guidelines](#) and [sample grant agreements](#) before filling out this application. We recommend you keep the guidelines open as you are completing your application so you can refer to them when providing your responses.

You may submit your application at any time up until 5.00pm AEST on 14 August 2023. Please take account of time zone differences when submitting your application.

B. Eligibility

We will ask you the following questions to establish your eligibility for the [grant opportunity name] grant opportunity.

Questions marked with an asterisk are mandatory.

- Select which type of entity your organisation is. *
- an entity incorporated in Australia
- state territory or local government body
- an Aboriginal and Torres Strait Islander Corporation registered under the Corporations (Aboriginal and Torres Strait Islander) Act 2006 (Cth) or other state and territory legislation

You must select one of the eligible options from a drop down menu to proceed to the next question.

Successful applicants must participate in training developed by DCCEEW via a train-the-trainer model.

- Does your project deliver the training package developed by the Department of Climate Change, Energy, the Environment and Water? *

You must select yes to proceed to the next question

- Does your project have at least \$1 million in eligible expenditure? *

You must select yes to proceed to the next question

- Can you provide all mandatory attachments outlined in the grant opportunity guidelines? *

You must select yes to proceed to the next section.

C. Applicant address

D. About your organisation

We collect the following data from all applicants across all grant programs. We use this data to better understand your organisation and to help us develop better policies and programs.

D.1. Latest financial year figures

All values must be whole numbers. For example

6.5 months should be presented as 7 months

\$2 million should be presented as \$2,000,000

Total revenue from the sale of goods and services, as reported in your organisation's Business Activity Statement (BAS).

- Export revenue

Total revenue from export sales, as reported in your organisation's Business Activity Statement (BAS).

- R&D expenditure

Expenditure on research and development, i.e. creative work undertaken on a systematic basis in order to increase the stock of knowledge, including knowledge of humankind, culture and society, and the use of this stock of knowledge to devise new applications.

- Taxable income

Taxable income or loss as per your organisation's income tax return form.

- Number of employees (headcount)

Number of individuals who are entitled to paid leave (sick and holiday), or generate income from managing your organisation. This should include working proprietors and salaried directors.

- Number of independent contractors (headcount)

Number of individuals engaged by your organisation under a commercial contract (rather than an employment contract) to provide employee-like services on site.

D.2. Your ANZSIC code

Provide from a drop-down menu:

- your organisation's main revenue earning division under the Australian and New Zealand Standard Industrial Classification ([ANZSIC](#)).

E. Project information

On this page you must provide the detailed information about your proposed project.

If your application is successful, we will publish some grant details on [GrantConnect](#) and other government publications. Published details include:

- *name of the grant recipient*
- *a project title*
- *a brief project description and its intended outcome*
- *amount of grant funding awarded.*

E.1. Project title and description

Provide a project title.

Your response is limited to 75 characters including spaces and does not support formatting.

Provide a brief project description.

Your response is limited to 750 characters including spaces and does not support formatting.

Ensure your project description focuses on your project's key activities and outcomes. Outline what it is you are going to do and how it will support Australian farmers and land managers to reduce emissions and contribute to Australia's climate change commitments.

E.2. Detailed project description and key activities

This information will be included in your grant agreement if your application is successful.

Provide a detailed description of your project including the project scope and key activities.

Your response is limited to 5000 characters including spaces and does not support formatting.

You must attach a project plan later in your application.

E.3. Project outcomes

This information will be included in your grant agreement if your application is successful.

Provide a summary of the expected project outcomes.

Your response is limited to 5000 characters including spaces and does not support formatting.

E.4. Project duration

Your project must be completed in line with the dates provided in the grant opportunity guidelines.

- Estimated project start date
- Estimated project end date
- Estimated project length (in months)

You must complete your project by 31 March 2026.

E.5. Project milestones

Provide details on the project milestones including the key activities occurring at each milestone. You can add up to ten milestones.

The milestone start and end dates must be between the project start and end dates.

- Milestone title

Your response is limited to 100 characters including spaces and does not support formatting.

- Description

Your response is limited to 750 characters including spaces and does not support formatting.

- Estimated start date
- Estimated end date

E.6. Project location

You must provide the address where your project will be undertaken and the estimated percentage of project value expected to be undertaken at that site. If you have multiple sites you must add the address of each site.

A project site must be a street address. Do not provide a postal address, institution or building name.

F. Project budget

F.1. Project budget summary

Provide a summary of your eligible project expenditure over the life of the project.

If you are registered for GST, enter the GST exclusive amount. If you are not registered for GST, enter the GST inclusive amount. We only provide grant funding based on eligible expenditure. Refer to the guidelines for guidance on eligible expenditure.

The minimum project expenditure for this grant opportunity is \$1 million.

F.2. Source of funding

In this section you must provide details of how you will fund the project.

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only consider funding applications that score at least 50 per cent against each criterion as these represent best value for money.

The amount of detail and supporting evidence you provide should be commensurate with the project size, complexity and grant amount requested. You should define, quantify and provide evidence to support your answers.

G.1. Assessment criterion 1 (50 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

Alignment to program objectives

You should demonstrate this by describing

- how your project will increase the awareness and knowledge of greenhouse gas emissions management amongst farmers and land managers
- how your project will support farmers and land managers to understand how to participate in carbon markets and integrate low emissions technologies and practices into their farming operations
- the reach and coverage of your project, including your target audience, cultural competency to engage participants, including First Nations groups (where appropriate), expected number of participants and geographic coverage
- your strategy to maintain the project outcomes beyond the term of the grant funding.

G.2. Assessment criterion 2 (40 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

Capacity, capability and resources to deliver your project

You should demonstrate this by identifying

- your capacity and capability to provide trusted and independent advice
- your track record managing similar projects and access to personnel with the right skills and experience, including management and technical staff
- how you will engage with relevant stakeholders and leverage existing connections to achieve your project outcomes
- your access, or future access to, any infrastructure, equipment, technology, intellectual property and required regulatory or other approvals
- how you will plan to manage and monitor the project including mitigating delivery risks and collecting participant feedback
- a sound project plan to manage and monitor the project, including a project budget.

G.3. Assessment criterion 3 (10 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

Impact of grant funding

You should demonstrate this by identifying

- describing the likelihood the project would proceed without the grant, and how the grant will impact the scope and timing of your project
- justifying the funding amount requested with respect to the scale of the project and intended outcomes
- the predicted outcomes of your proposed project
- any additional investment that the grant will leverage and explain how this benefits your project.

G.4. Assessment criterion 4 (10 points)
