

This document shows the questions included in the online application form for this grant opportunity. It will help you prepare your responses and the mandatory attachments you need before you apply online.

This is a sample only and may be subject to minor changes.

Do not use this document as your application form. You will need to submit an application using the online form once the grant opportunity is open to applications

Instructions

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

A red asterisk * indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

You can save your changes at any time by using the Save button. To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to the participant inviting them to assist with your application.

Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

A. Program selection

We need to first identify what type of entity is applying. If you are a trustee applying on behalf of a trust the details are slightly different.

A.1. Trustee and trust details

If you have selected trustee on behalf of a trust we require details of both trust and trustee. A trustee must be incorporated.

Trust details

We require the following details.

Your business may have registered one or more business name. If you operate under a business name, you must provide the alternative name.

A.3. Program selection

When you have selected the program, the following text will appear.

The Brain Cancer Survivorship Grant Opportunity aims to achieve increased patient survival, quality of life and care experiences, increased and equitable access and participation in clinical trials, expanded research platforms and technologies, and increased researcher capacity and excellence.

The objectives of the 2020 Brain Cancer Survivorship Grant Opportunity are to support the development of new approaches to:

- improving communications between brain cancer survivors, their families, carers and health care professionals
- understanding the impact of technology on the physical, psychosocial and economic sequelae of a brain cancer diagnosis.

Survivorship research must be focused on children, adolescents and young adults, or adults with malignant brain cancer, their families or carers.

You should read the <u>grant opportunity</u> and <u>sample grant agreement</u> before filling out this application.

You may submit your application at any time up until 5.00pm AEDT 20 October 2020.

B. Eligibility

We will ask you the following questions to establish your eligibility for the [grant opportunity name] grant opportunity.


Questions marked with an asterisk are mandatory.

Is your organisation incorporated in Australia? *

A legal entity is an entity in its own right that has capacity to enter into legally binding agreements or contracts, assume obligations, incur and pay debts, sue and be sued and be held responsible for its actions.

Is your organisation one of the following bodies? *

- a medical research institute
- a university
- a corporate Commonwealth entity
- a corporation (including businesses and not for profits)
- a state or territory government
- a state or territory government entity



C. Applicant address

C.1. Applicant street address


You must provide your street address

C.2. Applicant postal address

You must provide your postal address

When you start typing the address in the field you can select the correct one from the drop down list that appears. If it is not there you can enter manually.



D. Applicant financials

D.1. Latest Financial Year Figures

- Has the applicant existed for a complete financial year?
- If no, enter the number of months completed in the financial year to date.

D.2. Recent trading performance

You must provide the following financial information about the applicant organisation.

We collect the following data from all applicants across all grant programs. We use this data to better understand your organisation and to help us develop better policies and programs.

All amounts must show a whole dollar value e.g. \$1 million should be presented as \$1,000,000. The turnover value must be that of the entity that is making the grant application (the 'applicant'), regardless of whether the entity belongs to a consolidated group for tax purposes.

Sales Revenue (Turnover)

Total revenue from the sale of goods and services, as reported in your organisation's Business Activity Statements (BAS).

R&D expenditure

Expenditure on research and development, i.e. creative work undertaken on a systematic basis in order to increase the stock of knowledge, including knowledge of man, culture and society, and the use of this stock of knowledge to devise new applications.

Taxable income

Taxable income or loss as per the applicant's Business Income Company Tax Return form.

Number of employees (headcount)

Number of individuals who are entitled to paid leave (sick and holiday), or generate income from managing the business. This should include working proprietors and salaried directors.

Number of independent contractors (headcount)

Number of individuals engaged by the business under a commercial contract (rather than an employment contract) to provide employee-like services on site.

E. Project information

On this page you must provide the detailed information about your proposed project.

If your application is successful, we will publish some grant details on <u>GrantConnect</u>. Published details include:

- a brief project description and its intended outcome

E.1. Project title and description

Provide a project title.

Your response is limited to 75 characters including spaces and does not support formatting.

Provide a brief project description.

Your response is limited to 750 characters including spaces and does not support formatting.

Ensure your project description focuses on your project's key activities and outcomes. Explain what it is you are going to do and how it will benefit your organisation.

E.2. Detailed project description and key activities

This information will be included in your grant agreement if your application is successful.

Provide a detailed description of your project including the project scope and key activities.

Your response is limited to 5000 characters including spaces and does not support formatting.

E.3. Project outcomes

This information will be included in your grant agreement if your application is successful.

Provide a summary of the expected project outcomes.

Your response is limited to 5000 characters including spaces and does not support formatting.

E.4. Project duration

- Estimated project start date
- Estimated project end date

The project length will be calculated by the start and end dates you enter. Your project can be no longer than 36 months.

E.5. Chief investigator

Has your Chief and/or Lead Investigator been nominated as the lead in any other applications in this round? *

The Chief and/or Lead investigator is a key researcher who has the required expertise and will lead the project. The leading investigator must be the lead on only one project in this funding round.

E.8. Project location

You must provide the address where your project will be undertaken and the estimated percentage of project value expected to be undertaken at that site. [If you have multiple sites you must add the address of each site.]

A project site must be a street address not a postal address.

Grant funding requested

You will be asked to enter the amount of grant funding you are requesting. Validations will limit your request to be within the grant opportunity guidelines.

G. Assessment criteria

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only consider funding applications that score satisfactorily against each criterion as these represent best value for money.

The amount of detail and supporting evidence you provide should be commensurate with the project size, complexity and grant amount requested. You should define, quantify and provide evidence to support your answers.

To support your responses you must include mandatory attachments later in the application.

Your response is limited to 5000 characters for each criterion including spaces and does not support formatting.

G.1. Assessment criterion 1 (40 points)

Project impact

Assessment criteria as per the guidelines

You should demonstrate this by identifying

- a. how your project will improve the quality of life and the survivorship experience through:
- the development of new approaches and the use of technologies to improve communications between brain cancer survivors, their families, carers and health care professionals, and/or
- improving understanding of how information technologies and platforms can be used to support people with brain cancer, their families and carers, and their impact on the physical, psychosocial and economic sequelae of a brain cancer diagnosis,
- as reflected by measurable project targets including, but not limited to:
 - enhanced communication strategies and approaches to improve quality of life and independence of brain cancer survivors
 - enhanced communications strategies that address the needs of brain cancer survivors, their families and carers

- the development of new approaches and the use of technologies to improve communications between brain cancer survivors, their families, carers and health care professionals, and/or
- improving understanding of how information technologies and platforms can be used to support people with brain cancer, their families and carers, and their impact on the physical, psychosocial and economic sequelae of a brain cancer diagnosis
- enhanced support services for patients
- enhanced capacity and capability for translational research within Australia's health and medical research sector
- informed future policies and processes to support people with brain cancer, their carers and their families
- how your project will deliver outcomes that are a priority for the Australian public (survivors, family and carers), including details of consumer and community engagement and involvement
- c. partnerships with health service delivery partners that will support implementation of study findings into practice, as quickly as possible
- d. how the research will provide outcomes within 12 months of the grant period ending
- e. how your project includes new and innovative approaches, that can be scaled nationally
- f. how your project builds on and supports other initiatives, if applicable.

G.2. Assessment criterion 2 (30 points)

Project methodology

You should demonstrate your proposed approach to delivering the project by providing:

- a. your project plan, including:
- an outline of the activities you will undertake, demonstrating:
 - o a clear research question
 - consumer engagement through the research journey (from inception of research question to implementation of outcomes)
 - the methods being appropriate for the research question and described in sufficient detail
 - o feasible research design and clearly demonstrated expertise, tools and techniques
- appropriate milestones, performance indicators and timeframes for delivery
- the governance structures in place for the project
- b. a project feasibility analysis.

G.3. Assessment criterion 3 (30 points)

Capacity, capability and resources to deliver the project

You should demonstrate this by providing details of:

- a. your access to, and/or a feasible plan to recruit, an appropriate, multi-disciplinary team, with proposed key project personnel, their skills and experience clearly articulated, along with explanations of how their skills and experiences are important to the success of your project
 - examples must be provided on each investigator of how their research has impacted policies or programs, through the translation or implementation of their research findings
- b. previous capacity and impactful research conducted in partnership with consumers and/or community members
- c. your track record in managing similar projects
 - consideration should be given to the project team's expertise in all aspects of the
 proposal, including the methodological and scientific underpinnings (e.g. statistics,
 psychology, sociology, social sciences, and consumer and community
 engagement/involvement), the team's previous research outputs demonstrating a
 capability to undertake the research project, and delivery of high quality research
 outputs in this area.

G.4. Assessment criterion 4 (1 Points)

Overall value and risk of the project (non-weighted)

Your response is limited to 5000 characters including spaces and does not support formatting.

You should demonstrate the overall value and risk of the project, including that you have robust risk identification and management processes.

You should provide:

- your proposed budget and justification
- a risk management plan.

Our assessment will also take into consideration:

- the suitability of your proposed budget to complete all project activities
- how well the requested budget has been detailed and justified
- how soundly your risk management approach is demonstrated
- any risks identified as part of the assessment of your application
- the appropriateness of the submitted risk management plan in documenting key risks to the completion of the research proposal, including your plan to manage those identified risks, and
- how you propose to monitor and report risks (both those identified in your submitted risk management plan and those which may arise during your project).

H. Project partners


You must provide details about your project partners.

For details about project partner refer to the grant opportunity guidelines.

You must appoint a lead organisation. Only the lead organisation can submit the application form and enter into the grant agreement with the Commonwealth. The application should identify all other members of the proposed group and include a letter of support from each of the project partners. You can attach letters of support when you add each partner.

Each letter of support should include:

- details of the project partner
- an overview of how the project partner will work with the lead organisation and any other project partners in the group to successfully complete the project
- an outline of the relevant experience and/or expertise the project partner will bring to the group
- the roles/responsibilities the project partner will undertake, and the resources it will contribute (if any)
- details of a nominated management level contact officer.

Risk management plan *

A detailed risk management plan, and any supporting documentation, describing how you propose to monitor, manage and report identified risks including risks that may arise during your project
