## Instructions

---

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

### Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

A red asterisk \* indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

You can save your changes at any time by using the Save button. To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

### Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to the participant inviting them to assist with your application.

### Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

## A. Program selection

---

We need to first identify what type of entity is applying.

*Some programs we offer allow entities without an ABN to apply. The form is designed to accommodate these entities. However for this grant opportunity, an ABN is mandatory, If you do not have an ABN this grant opportunity will not appear in the program selection at the bottom of the first page and you will not be able to continue.*

If you are a trustee applying on behalf of a trust we will need details of both the trust and trustee.

Before you start you should have the following details ready if they are applicable to you.

If you do not have an ABN we will ask you why you do not have one. You should note the following.

*If you are entitled to an ABN and do not provide it to us, we will be required to withhold 47 per cent from any grant awarded. If you intend to apply for an ABN you should do so before starting your application as you cannot update these details in the application form. If you apply for an ABN after you start your application you will need to start again.*

The objective of this grant opportunity is to provide grants of financial assistance to support early stage Australian medical research and medical innovation projects in the following four streams:

- **Stream 1:** preclinical medical research or medical innovation projects with commercial potential
- **Stream 2:** early clinical development of novel drugs, or novel uses for existing drugs, with commercial potential
- **Stream 3:** early clinical development of medical devices with commercial potential
- **Stream 4:** early stage development of digital health technologies with commercial potential.

Each will be a separate funding stream. The top ranked project in each Stream will be funded.

You may submit your application at any time up until 5.00pm AEDT 1 April 2021.

## B. Eligibility

---

We will ask you the following questions to establish your eligibility for the MRFF 2020 Early Stage Translation and Commercialisation Support Grant Opportunity.

### E.4. Project duration

## E.5. Grant Stream

### Grant funding requested

You will be asked to enter the amount of grant funding you are requesting (must be \$19.75 million).

### F.2. Source of funding

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only consider funding applications that score satisfactorily against each criterion as these represent best value for money.

*The amount of detail and supporting evidence you provide should be commensurate with the project size, complexity and grant amount requested. You should define, quantify and provide evidence to support your answers.*

To support your responses you must include mandatory attachments later in the application.

### H.1. Assessment criterion 1 (40 points)

#### Project impact

##### Assessment criteria as per the guidelines

*Your response is limited to 5000 characters for each criterion including spaces and does not support formatting.*

You should demonstrate this by identifying

- a. how your proposed activities will increase the number of Australian medical research and medical innovation projects progressing through the early stages of research and development to the point where they are 'de-risked' and attractive to private investment for commercialisation, reflected by measurable project targets
- b. how the proposed activities will enhance the capacity and capability of Australia's health and medical research sector to translate and commercialise health and medical research outputs
- c. the extent to which your proposed activities will support delivery of commercialised health and medical research outputs, leading to the improved health and wellbeing of the Australian public
- d. how the research will provide outcomes within 12 months of the grant period ending
- e. the extent to which your proposed activities include new and innovative approaches
- f. the extent to which your proposed activities build on and support other related initiatives.

You should demonstrate how the outcomes or results you have identified against the MRFF Measures of Success are relevant and meaningful to the goal and aims of the Initiative.

### H.2. Assessment criterion 2 (30 points)

#### Project methodology

You should demonstrate your proposed approach to delivering the project by providing:

  - an outline of the activities you will undertake
  - appropriate milestones, performance indicators and timeframes for delivery
  - the governance structures in place for the project

- b. a project feasibility analysis.

### **H.3. Assessment criterion 3 (30 points)**

#### **Capacity, capability and resources to deliver the project**

  - identifying proposed key project personnel, their skills and experience clearly articulated, along with explanations of how their skills and experiences are important to the success of your project
  - describing how you will identify, engage and seek input from expert reviewers and assessors as part of the selection of eligible Australian SMEs
- b. your track record in managing similar projects
  - consideration should be given to the project team's expertise in all aspects of the proposal, including evidence supporting the team's capability to select, manage and support successful Australian SMEs to progress their research.
- c. your access, or future access, to any required infrastructure, land, capital equipment, technology, and regulatory or other approvals.

- the value of any financial and/or in-kind contributions from partners
- the relative contribution of the outcomes or results you have identified against the MRFF Measures of Success to the goal and aims of the Initiative
- how soundly your risk management approach is demonstrated
- any risks identified as part of the assessment of your application
